**Literature,** David S. – I have received word from GSO literature will be going up about 20% in April. I will put new price lists up in the red house office. Big Books will be \$12 instead of \$10. sell. We have a lot of money tied up in those books that are not moving at all. I'd like to offer those old books at a discounted price. We do need the space for the new literature we order. This way I could order more big books at a time for lower prices.

Outreach is always looking for members. We have 4 of us now. The Area Assembly is this Sat. and there will be a service fair.
